- d) A regular network of academics with expertise in engagement (with past award winners taking a key role) will replace the current Engagement Executive; supported by ARM and with input from REN, the network will provide a forum for innovation and good practice in the area of public engagement;
- e) A member of Executive Team will provide the academic lead on engagement ensuring oversight of training, support and web presence. For 2016/17 this will be Dean HUM, current Chair of Engagement Executive.
- f) Arrangements to be reviewed for effectiveness in May 2017.

(Senate noted that development work would be required on PURE before it could be used in this way which may delay the implantation of recommendation b).)
